

# **EITC Awareness Day Communications Guide**

The National League of Cities (NLC) <u>Institute for Youth, Education, and Families</u> have worked with local leaders to implement Earned Income Tax Credit (EITC) outreach campaigns <u>for more than 20 years</u>.

These campaigns have helped to raise awareness of the tax credit and increase the participation of low- and moderate-income residents. As this work has grown, we've helped cities develop new partners with existing local Volunteer Income Tax Assistance (VITA) programs to help their residents access this important tax credit through a trusted source.

It is through these collective efforts that more than \$62 billion of federal dollars are brought back to local economies every year. In 2022, qualifying families with three or more children could receive \$6,728.

If you're interested, we are happy to help you advance your work in this space.

On **Friday, January 28, 2022**, we will be celebrating the 16<sup>th</sup> annual <u>EITC Awareness Day</u>. This day is an effort by the IRS to encourage local governments, community organizations, and other stakeholders to bring attention to the EITC and opportunities for free tax filing services through virtual VITA, and via GetYourRefund.org.

This communications guide has been created to help you celebrate the day, connect with VITA partners, and raise the visibility of this important tax credit for your residents. It includes a <u>template press release</u>, a <u>sample email to partners</u>, a <u>city proclamation template</u>, as well as <u>sample social media posts</u> which you can tailor to meet your needs.

### **EITC Awareness Day Draft City Proclamation**

WHEREAS, since its enactment in 1975, the Earned Income Tax Credit has lifted millions of families above the poverty line and has had a high participation rate relative to the other programs targeted at low-income Americans; and

WHEREAS, working [CITY NAME] families may be missing out on a federal refund of up to \$6,728 for a family with three children because they are not aware of the Earned Income Tax Credit; and

WHEREAS, new parents, grandparents raising grandchildren, and foster parents may not realize they qualify; and

WHEREAS, employers, at no additional cost to themselves, can increase the take-home pay of their employees; and

WHEREAS, in 2020, approximately 25 million taxpayers received about \$62 billion in Earned Income Tax Credit: and

WHEREAS, these dollars are being spent within the local economy and are additional investments in our business community; and

WHEREAS, EITC Awareness Day was established as a day celebrating the EITC on the last Friday in January; and

WHEREAS, the IRS works with national partners, community-based coalitions, and thousands of local partners and governments that provide free tax help, otherwise known as Volunteer Income Tax Assistance (VITA), and education about EITC; and

WHEREAS, EITC Awareness Day is a day where cities and residents work together to spread awareness of the tax credit and help build a stronger economic community.
