

FY2023-FY2024 Membership Dues

The National League of Cities Board of Directors voted in 2017 to implement a policy to adjust dues annually based on the Consumer Price Index (CPI), with a maximum dues adjustment of three percent (3%). The membership dues adjustment for FY2024 is 3%, effective October 1, 2023. In addition, with the final 2020 U.S. Census numbers being released, NLC has transitioned to 2020 population numbers for FY24 dues. This means some members may see a shift in categories after FY23 due to population changes between the 2010 and 2020 counts.
