Cities for Early Childhood Success:

Prenatal-to-Three Impact Lab

OVERVIEW

The National League of Cities (NLC) will select **up to 16 cities** to participate in a hybrid learning and action series designed to help city leaders and municipal teams integrate prenatal-to-three (PN-3) strategies into their city's priorities. Through expert-led content, peer learning cohorts, and tailored coaching, city teams will identify actionable commitments, build cross-sector partnerships, and drive meaningful local action. The series will focus on strategies to address key contributors to poor maternal and infant outcomes, including **climate & environmental factors, family economic insecurity, and housing instability**, with each city selecting one focus area to drive targeted impact.

This Impact Lab aims to catalyze cross-sector collaboration, encouraging cities to embed PN-3 priorities into planning, infrastructure, and policy efforts that advance broader community goals, health equity, and resilience.

If your city is ready to take action to improve outcomes for young children and families, this program is for you.

BACKGROUND

The National League of Cities' Early Childhood Success (ECS) team collaborates with local leaders from over 80 cities, towns, and villages to build equitable systems that support young children and their families. The ECS Team's mission is to improve city leaders' capacity to reach across neighborhoods, align programs, and design policies that foster responsive, supportive communities of young children and their families. Guided by a vision where every city, town, and village have healthy babies and happy families, they strive for a future where all children are thriving by 3, ready at 5, and on their way by 8.

The first three years of life are the 'brick and mortar' of brain development, setting the foundation for all learning. During this time, the brain develops at a speed faster than at any other point later in life. Understanding the vital role Government leaders play a vital role in advancing outcomes for children and families during this period, NLC's ECS team works to build the capacity of municipal leaders and stakeholders to build awareness and infuse a prenatal-tothree agenda to improve outcomes for children, families, and those who care for them.

ABOUT THE IMPACT LAB

The Prenatal-to-Three Impact Lab offers a 9-month cohort experience designed to strengthen municipal leaders' capacity to drive meaningful policy and practice change for young children (0-8) and families.

Selected cities will receive support to:

- Integrate early childhood frameworks with climate and environmental initiatives that promote healthy air, green space, and sustainable neighborhoods.
- Embed early childhood and family-centered strategies in economic development efforts that enhance financial stability and workforce participation for parents and caregivers.
- Connect housing policies to the specific needs of expectant parents and families with infants and toddlers, ensuring access to stable, safe, and affordable homes.

Through this initiative, we aim to demonstrate how cities can lead the way in building systems that not only respond to the needs of their youngest residents, but also advance broader community goals, health equity, and resilience.

WHAT CITIES WILL GAIN

- <u>Strategic Insight</u>: A deeper understanding of the critical intersections between early childhood development and key municipal priorities
- Practical Strategies: Access to real-world examples and tangible strategies to integrate the prenatal-to-three population into municipal programs, policies, and practices.
- <u>Peer Collaboration</u>: Opportunities to engage with fellow city leaders in topic-based learning cohorts, sharing challenges, solutions, and progress.

Expert Guidance: Direct support from NLC staff and national partners through coaching, cohort calls, and one-on-one consultations to refine and advance local action plans.

TEAM COMPOSITION/ TIME COMMITMENT

To successfully integrate the prenatal-to-three population into municipal programs, policies, and practices while driving meaningful local action, crosssector collaboration is essential.

The Impact Lab requires cities to assemble a core team of individuals who will be engaged in the process throughout the 9-month cohort. Team members commit to attendance at all Impact Lab events and independent city work between sessions, totaling approximately six hours a month.

In developing the core team composition, cities are required to include:

◆ A team leader who will serve as the main point of contact with NLC, as well as convene the city team and coordinate work on deliverables.

 City staff who lead current community engagement work

 Individual(s) with decision-making ability who can drive policy and systems change.

In addition, teams are encouraged to include:

◆ Community members or community organizations deeply connected to the communities they serve (e.g., frontline service providers, community organizers, neighborhood groups)

 Funding and other strategic partners (E.g., United Way, community foundations)

Selection Criteria

We seek proposals from cities that recognize the foundational importance of early childhood development, particularly the first three years of life, as a lever for long-term community health, equity, and resilience. The city teams selected to participate in this cohort will be evaluated based on their responses to the questions outlined in this RFP.

In their submitted applications, successful applicants will demonstrate:

- 1. Support of the mayor and/or city manager for participation in the Impact Lab.
- Readiness and commitment to assemble an effective core team as detailed in 'Team Composition.'
- Commitment to participation in the full Impact Lab programming including the in-person convening, 1-1 technical assistance sessions, learning cohort calls and independent preparation.
- 4. Dedication to improving outcomes for young children and families in their community.
- 5. A commitment to sustain meaningful engagement with the community beyond the period of the Impact Lab.
